Itinerary

Day 1: Thursday, April 22: Uvalde / New Orleans / Palm Beach → Merida, Mexico (740 / 550 / 630 NM)

We will meet this morning at the Uvalde (New Orleans/Palm Beach) airport for a briefing before our flight to Merida. In addition to weather and safety, the international flying experience will be covered. Air Journey will do the eAPIS filing for all pilots.

Upon arrival, we will transfer to the Hacienda Temozon.

We will end the day with a welcome cocktail and dinner. Dinner will be accompanied with Mariachi players.

Day 2: Friday, April 23: Merida

Breakfast at the hotel.

Terms & Conditions

Passports are mandatory for the Journey.

Air Journey has quoted this itinerary with a minimum participation of 7 aircraft.

The Registration fee includes:

- Extensive Navigation log (airports, route, frequencies, information of airspace, nav-aids, reporting points, international flight plan) tailored for each aircraft
- Flight plans and eAPIS manifest (departure and arrival) filed on your behalf (one year subscription to Easy Air Journey included)
- 2010 Bahamas and Caribbean Pilot Guide, VFR charts, IFR low or high en route (based on aircraft type and pilot's preferences)
- Flight bag and collared, cotton shirt for the pilot with his name and aircraft tail number embroidered on the upper front. Additional shirts are available for passengers and crew at an additional cost.

Cancellation, refunds:

- a) **Cancellation by the client:** Is always required in writing and is subject to the following schedule of dates, whereby some or all moneys paid will be retained:
 - i) Given outside of 30 days of departure: AJ retains only the plane registration fee
 - ii) Between 30 and 15 days of departure: AJ retains 50% of the tour cost
 - iii) Between 14 and 5 days of departure: AJ retains 75% of the tour cost
 - iv) 4 days or less or No show of departure: AJ retains 100% of the tour cost
- b) **Cancellation by AJ:** Should AJ cancel the tour after deposits have been received due to fewer than the minimum participants required, the full deposit will be refunded. Should AJ cancel the tour at any time due to factors beyond their control (including war, flood, force of nature, riot, civil action), they will refund the client whatever portion of moneys are reimbursed by ground operators and accommodation suppliers.
